Egypt.	June 1		Camp Adjutant, Garawi, is unable to get refrigerators so I approached B.T.E. but received little satisfaction. Abbassia refused to act on large indent for missing gear without approval from BTE. Promulgated instructions regarding re-equipping of the Div. Drew more Sect. K war equipment. 4 Bde. arrived back from Crete to find their area complete in every respect.
	2		Div. HQ personnel, including all ordnance staff except S/Sgt Ashcroft and Pte Gracie, arrived back from Crete. It appears Ashcroft & Gracie are prisoners of war. Contacted D.D.O.S. BTE and the refrigerators and missing equipment required urgently for Garawi Camp were released for issue. Drew three cars from Middle East pool for G.O.C., Brigs Puttick and Hargest. Went to Middle East and saw G(SD) about more transport. Only success a promise of more M/cycles. Did, however, manage to obtain authority for the issue of 30 bicycles.
	3		Went to BTE with DDOS & DADOS(E) to see what equipment BTE had available for the 6 Bde. Answer - nil. Saw ADOS(P) at Abbassia about steel cupboards - not very successful. Visited gunshops and saw OME's and OR's at work on their course. Sent to No. 5 BOD urgently for hositops.
	4		Drew Brens, Mortars, Thompson Sub-M/G's and Signalling equipment previously authorised for issue from No. 5 BOD. Obtained authority from ME for issue of 10 steel cupboards. Sent most of the staff just returned from Crete on holiday. Allocated tools towards completing 24 (including 3 different types) armourers' kits.
	5		Together with DDOS went to Tel-el-Kebir and saw COO, DCOO and ADOS(P). Hastened completion as far as possible of our bulk I.O's for war equipment for the Div. Then on to 6 Bde HQ at Moascar - saw Brig., B.M., S.C., B.W.O. and O.M.E. Arranged for OME to endeavour to draw his 1098 equipment and also learnt of main deficiencies of equipment urgently required by the Bde.

RE-EQUIPMENT OF N.Z. DIVISION.

1. The re-equipment of the N.Z. Division is being done under a system promulgated by the D.D.O.S., 2 NZEF.
2. This has been designed for the threefold purpose of:
 - (a) Facilitating rapid submission of requirements to RAOC.
 - (b) Avoiding the laborious submission of indents by units.
 - (c) Excluding the necessity of vouchers from RAOC to units.
3. Units are not required to indent for any initial war equipment other than their requirements in Section A 1; respirators complete in Section A 2; rifles, pull-throughs and oil-bottles in Section B 1. (NZ. All reinforcements will be completely equipped.)
4. The only other action required of units is that they collect from the Ordnance Depot (Area S) items of war equipment when requested by Ordnance representative.
5. In order to avoid congestion at the Ordnance Depot, it is essential that units make every possible endeavour to collect their stores as soon as possible after notification that they are available.
6. Procedure when taking over stores:
 - (a) Check stores.
 - (b) Sign two copies of appropriate NZEF 30 on which stores are issued.
 - (c) Note quantity of stores taken delivery of in note book.
 - (d) Allow storemen making issues of stores to initial each issue in the notebook.
 - (e) Vouchers for initial equipment issued by NZAOC will NOT be used.
7. Distribution of initial equipment will be made in accordance with instructions received from G Branch. Units are therefore requested not to worry ADOS re expediting equipment as every endeavour will be made to fulfill essential requirements as soon as possible.
8. In the event of any unit being detailed for a specific task requiring certain equipment not yet on issue, application for such equipment will be made to Div. HQ and the necessary steps will be taken to endeavour to supply as far as available resources will allow.
9. Full co-operation in the above instructions will permit of the re-equipping of the Division to proceed as rapidly and as smoothly as possible.
